BOARD OF GOVERNORS REPORT

To the Illustrious Commander in Chief, officers and brethren of the Connecticut Council of Deliberation at the Courtyard Marriott in Shelton CT on September 23, 2023.

Brothers, good afternoon and greetings from your Board of Governors.

Will the members of the Board of Governors who are present please virtually signify their presence in order to be recognized?

My Brothers, these dedicated volunteers continue to work to support the life changing tutoring provided by the dedicated team of tutors at the Children's Dyslexia Center of Connecticut. Please join me in offering your appreciation for their time and efforts!

As the tumultuous era of the Pandemic Shutdowns slowly recedes from our memories, the resumption of mostly in person tutoring services have resumed in earnest and have gained positive momentum. The three centers here in Connecticut have served 45 students for the scholastic year 2022-2023 up from 31 last year, or a 45 percent increase year over year. This past scholastic year we had 8 students being tutored in the Bridgeport satellite, six students in the

Hartford satellite and 21 at the main center in Waterbury. This Fall (starting September 2023) we have 12 students enrolled in Bridgeport (including 6 new students), 10 (including 6 new students) in Hartford and 20 (with Four new students) in Waterbury.

Our statewide staff head count is 11 people, consisting of: 2 people in Bridgeport, Including Co- Director Connie and one Tutor Kim,

2 people in Hartford, including Co- Director Paula and one Tutor, Dawn

7 people in Waterbury, including Director Cheryl, Office manager Dan, and 5 tutors, namely Joanne, Brianna, Deb, Joan and Claudia.

In terms of training endeavors this past year, three scholars are in the process of having completed Practitioner 1 training. Two additional scholars have been certified, three are working on their Practitioner 2 training and two others have completed and certified as Practitioner 2's.

For this coming Academic Year, 2023-2024 there are eight scholars working alongside staff and helping the students, they being distributed with Three in Bridgeport, Three in Hartford and Two in Waterbury. The opportunities for new scholars this year have been filled, however additional opportunities are to be expected in the next year. Any interested parties should express their interest directly to Director Cheryl Sharkis so that they can contacted as opportunities arise.

Fundraising efforts have met or exceeded the projected revenue budgets, and expenditures have been well controlled so as to be consistent with the expected amounts budgeted for this past year. In summary the finances are in order, in no small part due to the ongoing generosity of the sponsoring Valleys, and the success of fundraising efforts.

I remind everyone here that our next fundraising event is the Annual Dyslexia Walk and which will occur on Sunday October 1st in Waterbury at the usual venue at Noon. This is a key fundraiser for your Centers and I ask that as many of you as possible come out to support this outdoor event. Russ Griswold, along with Hal Elwell and Shane Dufresne, who stepped in after the untimely transition of Illustrious Brother Martin Macary are promoting and organizing the event and are proving to be formidable organizers. Russ continues to monitor events, and we hope that he can relinquish the event into the hands of these very competent brothers when he is ready to pull the trigger!

Your Board of Governors acknowledges the outstanding financial support that comes reliably from the Constituent Valleys in Connecticut. We also acknowledge the outstanding and selfless job that many Brothers in the Constituent Valleys have done to raise and contribute donations for your Centers all year long.

Our traditional fundraising is back in full gear with the Thanksgiving Day Turkey Trot and the Hartford 5K events becoming active and effective fundraising venues for us again. In addition, the Valley of Bridgeport's Annual December Holiday Party in Branford has continued to be a holiday bright light and has been a great success three years running. Illustrious Brother Jack Farkas continues to throw some of the best parties in the Masonic Universe:}

I must acknowledge the continuing and ever creative efforts of Illustrious Brother David Sharkis, 33°, who is finding new havens and involvements for the CDC nationally. I must also, as always, extend kudos to our State Management, Center Director Cheryl Sharkis, and Co- Directors Connie Voight and Dawn Valentini, as well as all of the Tutors and Tutor Scholars who diligently and effectively deliver the services that will enable our charges to overcome their individual challenges and enable them to help become fully

involved citizens who can rely on themselves to achieve a better life.

This budget is based on a Valley per capita tax of three dollars (\$3.50) per each member on its roll of membership in each of its bodies as of June 15, 2023. An increase of \$.50 over last year.

We further recommend that the Treasurer be authorized after the 31st day of July to expend funds at the same rate as in this budget, until the next fiscal year budget shall have been approved.

REPORT OF THE AUDIT COMMITTEE

To the Illustrious Commander-in-Chief, Officers and Brethren of the Connecticut Council of Deliberation in Session at Shelton, Connecticut on September 23, 2023:

The committee was established following the Connecticut Council of Deliberation session on September 15, 2018. The committee

has been charged with review of the information provided to the COD concerning its overall finances.

Observations and recommendations:

Financial reporting:

I received and reviewed the QuickBooks report of the Treasurer for the year ended July 31, 2023, and have included in our financial review the activity for the years ended July 31, 2020 through July 31, 2022 for comparative purposes. This reporting format provides a snapshot of financial trends and is a useful tool for leadership when considering whether short-term or long-term changes need to be made to revenue and expenses to minimize operational losses. The method of accounting for the Council is "cash basis." Thus, revenue is recognized when received. Expenses and assets acquired are recognized when payment is made. With regards to the July 31, 2023 and 2022 financial information, the transfer of the July quarterly distribution from the investment account, in the amount of \$1,453 and \$895 respectively, was not deposited until August. In both years I increased the checking account balance to reflect un-deposited funds to match the July disbursement in the BNY investment account. I have recommended the treasurer contact BNY and change the distribution payments from paper checks to an electronic funds transfer which will eliminate the timing issue. These minor adjustments were reviewed with the treasurer as part of my review process.

Trust investments:

Attached is a summary of the investment account holdings as of July 31, 2023, through July 31, 2021. The holdings are a selection of mutual funds. During the year four holdings were liquidated and the proceeds invested in six new and existing holdings. The value of the account holdings as of July 31, 2023, was \$262,212 as compared to the July 31, 2022 account value of \$250,796. Dividend and interest income from the investments were \$6,317. The portfolio realized a net gain of \$12,485 which consisted of reinvested capital gain distributions from mutual funds of \$1,612; realized losses from the sale of holdings in the amount of \$3,074, and net unrealized gains within the holdings in the amount of \$13,947. The unrealized gain represents the change in unrealized gains at the beginning of the year of \$1,402

and unrealized gains at the end of the year of \$15,349. Investment advisory fees of \$1,070 were charged against the account for the fiscal year. It is the practice of the COD to transfer the dividend and interest income quarterly to the COD bank accounts.

Governmental compliance:

On September 10, 2023, I reviewed the IRS filing information for the COD, and the five Valleys reported on the IRS Tax-Exempt Organization search page; IRS Tax Exempt Organization Business Master File database postings as of August 15, 2023. and Guide Star. Of the most recent returns listed, all but the Valley of Waterbury file Form 990 returns. The Valley of Waterbury files a Form 990-N and I am assuming the officers annually determine if they are not otherwise required to file Form 990 or Form 990-EZ. The IRS Tax-Exempt Organization Master File database is current and lists the last return processed by the IRS. The last Form 990(s) processed for the Valley of Bridgeport, Valley of Hartford, Valley of New Haven and Valley of Norwich were for the fiscal year ended July 31, 2022 and using Guide Star I was able to view the returns. The most recent Form 990-N, filed by the Valley of Waterbury, available online was for the year ended July 31, 2022.

I observed the Valley of Waterbury continues to use a home address when filing their Form 990-N. In my experience, this is a risky practice because the address on the return is the IRS address of record. Notices, including failure to file and loss of exempt status, are sent to the address of record. It is recommended the use the Valley building physical street address or a business P.O. Box, accessible by the secretary and treasurer for the return address.

• Revenue enhancement and cost mitigation efforts: Revenue comes from three sources: per capita assessments, dinner receipts and investment income. The COD has been proactive in forecasting expenses and adjusting the per capita assessments, accordingly. The benefit of this forward-looking approach of matching needed revenue to expected expenses creates financial stability for the council as seen for fiscal years ended July 31, 2023, and 2022.

Thank you for the opportunity to participate in this process.

REPORT OF THE SECRETARY

To the Commander-in-Chief, Officers and Brothers assembled in Shelton, Connecticut for our One Hundred Forty Fourth session of this Connecticut Council of Deliberation on this, the twenty-third day of September, 2023:

The proceedings of the 143rd session of this Council of Deliberation has been printed and posted to our websites for all our members to view, download or be referenced. The proceedings of today's 144th session of this Council of Deliberation will be created, printed and posted to our website for all our members to view, download or be referenced within the next few weeks.

All Actives, 33°'s, MSA's, current and past Heads of Bodies make up the permanent members of this Connecticut Council of Deliberation. This Connecticut Council of Deliberation currently has 240 Permanent Members.

Total membership within the Connecticut Valley's now stands at 1918 (a loss of 37). Taking a detailed look at the 1918 members we started this year with, we find:

- 51%, or 978 members, are 70 years old or older.
- 31%, or 594 members, are 60 years old or younger.

The breakdown of the State-wide membership is as follows: Collectively, we Initiated 76, Affiliated 1, Restored 10, Suspended 25, Discharged 5, and Demitted 5 members this past year. We have also reported a total of 89 Deaths. Together, this represents an overall loss of 37 members from the previous year.

The Valley of Bridgeport finished the year with a gain of 3. The Valley of New Haven finished the year with a gain of 2. The Valley of Waterbury finished the year with a loss of 8. And the Valley of Norwich finished the year with a loss of 14. The Valley of Hartford finished the year with a loss of 20.

The per capita tax of \$23,016.00 has been sent out; all Valleys have submitted their payments.

All underlying data used to create this report comes directly from Supreme Council's J365 Database (a graph of which will be provided in the CT COD Session Book).

REPORT OF THE COMMITTEE ON MEMBERSHIP

To the Illustrious Commander-in-Chief, Officers and Brethren of the Connecticut Council of Deliberation in Session at Shelton, Connecticut on September 23, 2023.

In the last year all Valleys have returned to holding both large in person degrees and social events. Valleys continue to hold a wide variety of events to satisfy the interest of every person such as community events like 5k runs, charity walks and marching in parades, to wine and beer tastings, fishing trips, trips to see plays and concerts, summer picnics, holiday parties, cigar rolls and axe throwing. These events help keep members interested and engaged in the Valleys.

With all three Connecticut Valleys attaining the esteemed title from the Supreme Council as a Valley of Excellence, valleys should put an emphasis on Membership, Service and Philanthropy, Leadership Development and Operations. Delegating responsibilities to other members of the valley such as a family life chairman helps build each member's participation and with a multitude of options for all types of service, provides opportunities for fellowship and building bonds.

This committee highly recommends that each Valley in Connecticut utilize initiatives to strengthen its membership experience. These initiatives include: · Seven virtual Masonic Exhibits · Valley of Excellence Program · 32nd Degree Member Kits · The New Member Experience support materials · "Not just a man, a mason" promotional materials CONNECTICUT COUNCIL OF DELIBERATION 51 · Hauts Grades Academy Educational Program · Additional Leadership Materials · "You're Invited" Brochure · Online Petition, process, and payment · 4th Degree "Induction Ceremony" with Welcome package · A redesigned Northern Light magazine PATHFINDER "Extend the journey to further light in Masonry "Through participating in various activities and exploring the resources of the Scottish Rite, to help each member become the best version of the man that they can be. . Details regarding these programs can be found in the Northern Light magazine, the Supreme Council website (scottishritenmj.org), or can be presented by the chairman of this

committee. We highly recommend that all valleys continue to promote these programs within its membership.

Ongoing Recommendations: The State Membership and Retention Committee continues to recognize that there are two primary concerns facing our committee that require our strict attention and focus; recruitment and retention. Successful recruitment and retention both necessitate that our Rite develop an environment that is simultaneously inspirational, convenient, and enjoyable for both potential members and existing members.

Although there is no uniform program for membership and retention across our state, we need to remember many masons who join the Scottish Rite are seeking further light in Freemasonry. Light in Freemasonry is only transferred from brother to brother. It is important that all the members work to make everyone welcome at reunions. Going the extra step to introduce yourself to a new or visiting brother will increase that brother's likelihood to return in the future. Verbally invite new members to family life events. Ask new brothers what they are looking for in the Scottish Rite and help direct them towards that masonic light they seek in the Scottish Rite.

Perhaps a welcoming team would be a good idea. This would consist of a small group of brothers who would focus on ensuring that all members of the Rite attending a reunion feel welcomed and informed. By introducing new brothers to other brothers who have similar interests a welcome team can help make a new or returning member feel very comfortable.

One Valley has made the effort to form a new membership committee for the 2023-2024 year. The committee is focused on the Lodge ambassador program and is going to train the ambassadors and have them look for opportunities to get the Rite into the lodges. Focus will grow into establishing more Rite on the Road opportunities. The valley is looking to promote their degree teams to help the lodges with the BLUE wave. The committee is looking to create and sponsor more Mason/Non-Mason/ Scottish Rite Nights like Scotch and Cigar Nights.

Brothers of different ages communicate differently. For example, some brothers communicate primarily through electronic means, while others still strictly use traditional means. Although it may be

tempting to only focus on the latest innovative technologies in communication, we must adopt a multi-faceted approach that meets the needs of all our members. Our communication needs to be in the form of several approaches to ensure that we reach all our members.

We need to continue to produce and distribute high-quality traditional postal bulletins. Having a physical copy that lists the most important details of our valleys, its programs and calendar is immensely valuable. Many of our valleys produce high quality publications that supply our brethren with information, while at the same time can be used as a recruitment tool highlighting the benefits of the valley. We recommend that the distribution of these publications be opened beyond the members of our valleys and include all Grand Lodge and local lodge leadership. The extra cost of printing in the Connecticut Freemasons as a supplement is well worth it and demonstrates our support for our Blue Lodges.

We need to step up our marketing of social events, the use of colorful and informative event fliers that are physical as well as electronic will help encourage all the craft and increase participation. The valleys need to continue with consistent and frequent email notification programs. Some Valleys send out several a week and are having good open communications with the craft and increasing the participation at reunions and family life events. Some Valleys have a strong social media presence, but some do not. These valleys are having very successful family life events such as: Chartered boat fishing trips, Scotch and cigar nights, Winery bus tours, Museum and special location trips like the Supreme Council Museum, Trips Outside of the State to places like Gettysburg and Arlington, VA; Sporting, Picnics and family outings, and Clambakes.

The Valleys have and should continue to work together to hold reunions, and this appears to be welcoming to the craft. All the Valleys should be working hand in hand and work together to have reunions. This effort will help share the workload and encourage brotherhood across the valleys. By conferring degrees with a large cast in the presence of hundreds of Scottish Rite Masons we inspire awe in our new brethren and energize our existing membership. Valleys should work together and avoid negative comments about not wanting to do something another

valley is doing. In order to grow and survive as a state we all need to work together for the benefit of the COD and the Rite as a whole.

The committee would like to commend the efforts of our brethren across the state, who have tirelessly dedicated themselves to make the Scottish Rite experience a fantastic journey towards further light in Masonry. The Supreme Council has made membership its primary focus. It has developed a wide range of programs, services, and initiatives to help support all Valleys. These programs should be used to enrich the Scottish Rite experience and encourage Blue Lodge masons to join the rite.

Connecticut Council of Deliberation Historian Report

Martin Ede, Chairman Arnie Grot

To the Illustrious Commander-in-Chief, Officers and Brethren of the Connecticut Council of Deliberation meeting in session at Shelton, Connecticut on September 23rd, 2023.

As chairman of the historian committee, a number of thoughts of what to put into writing occurred to me. Recently though, due to questions asked a couple of those thoughts firmed up. They highlighted the two parts of the duty of a historian. First a question of records and their location came up. Secondly, the joy and fascination of research came up in the paper submitted by fellow committee member Bro. Arnie Grot, attached to this report, on a Scottish Rite/Templar watch fob acquired by a Brother an ocean away.

The first part deals with a very simple question: Where is the charter of the Valley of New Haven? We all assume that important documents such as this are safely tucked away. So

safely, that no one was sure where. In conversations with older members, it might have been in a safety deposit box at one time. It was not in the office, but maybe in the safe shared with New Haven Commandery at the Masonic Temple. Luckily, as Recorder for the Commandery, I had access to the safe, but had no kevs for the cabinet or closets on the SR side. No sets of kevs had been found by our current secretary so we might have been left with the task of breaking in or getting a locksmith. Fortunately, for another project I had acquired a number of sets of keys from my lodge that a previous secretary had collected, so I could try and gain access to lodge safes. It was unknown what many of these keys were for. It was with some relief that I found keys from these sets that opened the closets and cabinets (why this old secretary had collected all of these keys, I cannot say). In these cabinets I found the charter and other documents along with our minute books.

Though this may have seemed a straightforward problem relatively easy to solve, the absence of keys and a certain current knowledge of where things are stored potentially could have made it serious. Do you know where all your records from charters to minutes to memorabilia are? Do have the keys, more than one set and if you do who has them? When was the last time you checked to see if they are safely tucked away and in what condition are they? As historians, we should have the answer to these questions to hand, also, does your Valley have a historian? From the above example, I can safely say that this was the first time I had seen the charter in the 23 years I have been a member. Along with these thoughts, how many of you have read A History of the Ancient Accepted Scottish Rite in Connecticut by James Royal Case (published in 1967)? When was the last time you had a presentation on the history of your Valley? This book is filled with fascinating information from the earliest arrival of the Ineffable Degrees in Norwich in 1796, to the various attempts to get the Scottish Rite in Connecticut started and chartered.

One interesting quote contained in Case's book in the chapter on the history of the Council of Deliberation was by Fred H. Waldron 33° on the seal of the COD: "The Circle is a symbol of the Universe and Eternity, the Triangle a symbol of Deity, and also a representation of the Tetragrammatron. The 15 stars represent the 15 states in the Northern Masonic Jurisdiction, the figure 1867 the date of the first meeting of the Council of Deliberation. The

Compass surrounding the Blazing Sun, and covering the numerals 3, 5, 7, and 9, the Mystic Numbers of a Grand Elect Mason. The Skull and Cup are symbols of Mortality and the Misfortunes that assail us in the voyage of Life. "(p.94).

There is much to be found and shared with your brothers that may be so safely tucked away that they may be lost in a short time if you are not careful. In your Valleys, make the effort to see what you have, if any repairs/conservation are needed, and to appoint a historian if your secretary needs help. You may be surprised by what you find.

Our memorabilia that is sometimes lost is sometimes found again, and sometimes by a Brother as Brother Arnie relates in the following short paper:

Historian Research Report

To the Illustrious Commander-in- Chief, Officers and Brethren of the Council of Deliberation:

This is a story of a 33° of the Valley of Hartford that reinforces that we are joined as brothers even half a world away and a century apart.

A singular Circumstance via eBay

At precisely 10:30 AM on May 14, 2022, in Spring Grove Cemetery in the north end of Hartford a ceremony began with "We gather this morning at the grave of the Illustrious dead, guided by a singular circumstance. No, not a sprig of acacia but a pendant left by our Illustrious brother 97 years ago and bought by another brother, a half world away, on eBay. As a token of respect on the day he is knighted, for this newfound brother, we lay flowers on Sir Knight Silas Chapman, Jr.'s, 33° degree, grave."

Let's step back to the beginning of this tale. On February 15, I received an email from Br. Wibo Schepel, Lodge "Het Schietlood" No 215, The Hague, The Netherlands: "I recently purchased a gold KT Pedant via eBay, and only after receiving it discovered the engraving on the sides: Silas Chapman, Jr., Hartford Conn, Washington Comdy No 1 (see Pedant photo). Would it be possible for you to give me any additional information? I am currently scheduled to join the KT myself at Olivier de la Marche

Commandery Nr. 1 in Leiden (The Netherlands) on the 14th of May."

Through research, I and Brother Schepel, with help of our Brothers, discovered much about Silas Chapman, Jr., and his Masonic journey. Silas Chapman, Jr. (see Silas Chapman, Jr 33rd photo.jpg) was born on September 2, 1845, in Hartford, CT. In business he was reticent, clear-headed, and penetrating to the last detail, and by the time he died, he was known as a dean of insurance agents in Connecticut.

Br. Silas began his Masonic journey in St. John's Lodge No. 4 in Hartford where he was initiated on April 15, passed on April 22 and raised on May 6 in 1885. Also in 1885, he became a 32nd Degree Scottish Rite Mason, was exalted a Royal Arch Mason in Pythagoras Chapter No. 17, received and greeted as a Royal and Select Master in Wolcott Council No. 1 and created a Sir Knight in Washington Commandery No. 1. He served as Sovereign Master of Hartford Council, Princes of Jerusalem from 1888-94 and was crowned an Honorary Thirty-third degree Mason by the Supreme Council on September 21, 1897. He served as Treasurer of Washington Commandery No. 1, KT in 1888 and 1889. Brother Chapman was a very modest and unassuming man of a retiring disposition. That generous and charitable impulses were in his nature is attested by the fact that almost his entire estate. amounting to over \$1,000,000, was begueathed for use of Masonic, charitable, and semi-religious institutions. In reading the various biographies we found about Silas Chapman, Jr., I reflected on the Masonic leaders I have met on the level in my Masonic Journey. Most are like Chapman, are comfortable and lead by example, are modest and unassuming but most of all I consider each one of the most companionable of men. We respect them in their roles and what they have achieved. Each, in one way or another remind us that we when we gather are Brothers equal in our Fraternity yet unique in our abilities. This is our legacy.

On the day he was created a Knight Templar, Silas, as all Sir Knights declared: "I will wield my sword—in defense of innocent maidens, —destitute widows, —helpless orphans, —and the Christian Religion." Bequeathing his estate, he not only continued this declaration but left a sprig of acacia, his pedant, and in this singular circumstance reinforced that we are joined as Brothers even half a world away and a century apart.

On the morning of May 1, 2023, Br. Wibo Schepel and I met in Hartford, laid a bouquet of tulips in a mason jar on Silas Chapman, Jr.'s grave and then with his wife, daughter and son toured Bushell Park and the Connecticut Capital. The tale continues.

REPORT OF THE INSURANCE COMMITTEE

To the Illustrious Commander-in-Chief, Officers and Brethren of the Connecticut Council of Deliberation in Session at Shelton, Connecticut on September 23, 2023.

The committee submits the following report:

There was no business that came before the committee in the preceding year and therefore, the committee has nothing to report. However, the committee plans to meet in the next month by Zoom to discuss areas of potential concern to the Connecticut Council of Deliberation where the individual Valleys may not be paying specific attention.

Concern over liquor being served to our Brothers at an adjacent Masonic facility that has no liquor license after our degrees. The Committee has not looked into this issue to date, so it is not implying any violation by any Valley.

Valley sponsored parades including serving food at the facility to non-Scottish Rite, and non-Masons.

Is there a need for a separate D&O policy for officers, trustees and executive board members.

Concerns for Valleys that share their facility with other Masonic organizations. Are there potential unknown liability where the facility is rented to third parties?

These and other insurance issues will be examined in the following year.

We must do better in attracting new members and retaining "the old". This can only be accomplished by ensuring that our Reunions and Family Life Programs are

events that are inspirational, convenient and enjoyable. This, as well as being Brothers that truly fulfill our Masonic obligation to care for our members is the path to our future success. I believe that the Scottish Rite Brothers in Connecticut are striving to accomplish these goals and I am hopeful that soon we will be successful in "stemming the tide" and I look forward to a time when our gains in membership will exceed our losses.

Charities

The Valleys in Connecticut and Scottish Rite Brothers in Connecticut continue to support the Children's Dyslexia Centers of Connecticut. We currently support a Learning Center and two satellite locations. The Valleys and the Scottish Rite Brothers in Connecticut commit in excess of \$250,000.00 annually to the operation of our Learning Centers. I thank the members of all our Valleys for their outstanding support of this extremely worthwhile charity.

Our Valley Hospitalers and Almoners continue to assist distressed Brothers who are experiencing financial and personal hardships. These efforts are in furtherance of our vision statement, "We will strive to be a fraternity that fulfills its obligations to care for our members." These efforts are undertaken in conjunction with the Grand Almoner of the Grand Lodge of Connecticut Lodge and the Supreme Council's Grand Almoner, particularly when Valley resources are insufficient to meet the needs of the Brother in distress.

In addition, our Valleys provide support to our Supreme Council Scottish Rite Charities and community-based charities, such as food banks, fuel banks, homeless shelters, women's shelters, volunteer fire departments and the like, all of which bring recognition and honor to Scottish Rite Freemasonry, and Freemasonry as a whole.

Children's Dyslexia Centers

The Children's Dyslexia Centers of Connecticut just completed its 21st year of operations. Thanks to a very

dedicated staff led by Center Directors Cheryl Sharkis, Connie Vogt and Paula Richardson, the Waterbury, Bridgeport, and Hartford Learning Centers have now changed the lives of over two hundred and eighty (280) children. They have also trained fifty-six (56) tutors, many who have gone on to provide tutoring to numerous children outside our network. None of this would be possible without the unprecedented cooperation and support the Centers receive from all our Connecticut Valleys. This past year we tutored twenty-eight (28) children but just as important, we will certify five (5) new tutors, three (3) of whom plan on continuing as employees at our Bridgeport and Hartford locations. This will provide an opportunity to increase our enrollment in 2024.

The successful operation of these Learning Center locations would not be possible without our dedicated staff and tutors, the Board of Governors, and the extraordinary efforts of Cheryl, Connie and Paula.

I would like to express my deepest appreciation to all who have given of their time, talent, and treasure to make Connecticut's Dyslexia Centers so successful.

Scholarships

Upon receipt of twenty-five (25) applications for the Leon Abbott scholarships, Connecticut awarded eleven (11) Abbott Scholarship of \$1,000.00 each, providing recognition of the academic achievement of our youth. Additionally, forty-one (41) Valley scholarships will be awarded in varying amounts to deserving students in recognition of their academic achievements. Once again, III. Brother Jack Farkas, 33° chaired our Scholarship Committee. I would like to thank III. Brother Jack and the entire Scholarship Committee for their work this year.

Youth Groups

The Connecticut Council of Deliberation, Our Valleys and Members actively support our youth groups, DeMolay and

Rainbow for Girls financially and with our time and talent and by participating in their events.

Report of the Committee on Communications

To the Illustrious Commander in Chief, Actives & Active Emeriti, Officers and Brethren of this Connecticut Council of Deliberation, and all Scottish Rite and Special invited Guests, in annual session at Shelton, CT, this 23rd day of September 2023:

The Committee on Communications is striving to create and make available, to each Connecticut Valley, the means,

tools, and knowledge to help communications flow freely to all our members and potential Candidates. Our goal is to support membership retention and growth here in Connecticut.

This past year, due to some health concerns, I found myself on the other side of information; I was no longer supplying it, I was receiving it. As a result, I made a few observations during that time.

- Information was coming in just fine, but members didn't know what to do with it. So what did they do? Nothing; they waited for further instructions. Sometimes they received it and sometimes not. I received a call from a newer member, informing me he was asked to register to attend today's event. I looked him up as he told me his email address. He opened the invitation up multiple times on multiple days. That would be 36 times in 9 days.
- New Heads of Body's don't always know proper procedures. While I was away tending to health issues, I was informed that my Valley was trying to appropriate funds to have a mailbox installed, not knowing all official Valley USPO Mail go to our PO Box.
- Not all Heads of Body's know how to effectively communicate with their Officers. Some don't communicate at all. Just last week I was asked (by a Body Head) to look up contact information on an officer in his Line.
- 4. Some communication is consistently excessive. I found myself wanting to "opt out" due to the constant barrage of emails. 20 emails for this event, 25 for that event, 30 for another.
- 5. Desired information was hard to come by. Where were the nuts & bolts, the how to and next steps. Still waiting.

I love the premise of Masonry; to learn and develop new tools and practices that will better myself for the betterment of myself, my family, my Lodge, my community, and my Brothers in Masonry. This is a great answer to the issues I've identified here today. Let's provide marketing skills to those involved in marketing and correspondence. Let's develop communication skills to our Heads of Body's. Let's invest in our Officers to become able to effectively attract, process and maintain new members as we all know we need to do.

I propose we develop a statewide Officer Training and Leadership Development program to help us officers reach our potential and grow membership in our CT Scottish Rite. Perhaps we'll discover this new program will be highly sought after by many Masons in CT.

REPORT OF THE DIRECTOR

Children's Dyslexia Centers of Connecticut A Scottish Rite Charity

To the Illustrious Commander in Chief, Officers, and Brethren of the Council of Deliberations, in Annual Session in Shelton, Connecticut on September 23rd, 2023:

Good morning and greetings from all of us at the Children's Dyslexia Centers of Connecticut. I am Cheryl Sharkis, the Director, Trainer, and Tutor at the Waterbury Center.

We are proud to report to you that the Children's Dyslexia Center continues to develop and progress forward. We have celebrated the achievements of more than 128 youngsters. Upon completion of their work at the Center, all have progressed at least 2 to 3 grade levels in their reading skills. with many surpassing this average. The most current ceremony was June 5th, with 8 youngsters completing their work at the Centers: 2 from Hartford Area, 2 from Bridgeport. and 4 from Waterbury. At present, we have experienced 20 Celebration of Achievement Ceremonies, Alumni continue to periodically stop by to share their achievements and upcoming plans. We are thrilled and moved that they are willing to take time out of their busy schedules and remember their Tutors. There is no feeling better than knowing that you have made a positive difference in a person's life!

The Centers' Staff currently includes 4 Practitioners, 1 Tutor, 4 Practitioner 2 Tutors, 1 Supervisor, 1 Co-Director completing her Practitioner 1 Instructor studies and 3 Tutors studying for Practitioner 2 certification. In total, the Center's Scholar Training program has certified more than 45 (+3 soon) Tutors. Our next Scholar training cycle is scheduled to begin September 22nd with Scholars, 2 in Bridgeport, 3 in Hartford, and 1 in Waterbury.

The Centers are currently providing tutorial sessions to 4 youngsters in the Hartford Area (+6 in Oct.), 7 in Bridgeport (+4 in Oct.), and 16 in Waterbury (+2 in Oct.).

Once again, we have finalized each youngster's annual progress assessment and we are thrilled to report that everyone is progressing and developing, with the gap between their grade levels and performance levels reducing significantly. There are approximately 28 youngsters remaining on the waitlist. If you know of a child who may benefit from participating in the Children's Dyslexia Center Program, please encourage their families to contact the Center.

Our Office Business Manager, Mr. Dan, has been very successful in corresponding with families, prospective trainees, and headquarters electronically. REPORT OF THE SCHOLARSHIP COMMITTEE

To the Illustrious Commander-in-Chief, Officers and Brethren of the Connecticut Council of Deliberation, meeting on September 23, 2023, the 144th COD Session, meeting in Shelton, CT:

This year, The Supreme Council, located in Lexington, Massachusetts has awarded \$11,000.00 to Connecticut for Abbott Scholarships. The State of Connecticut awarded Eleven One Thousand Dollar Abbott Scholarships. The State Scholarship Committee of the Connecticut Council of Deliberation has recommended eleven applicants to become the 2023 Abbott Scholarship recipients. Following tradition, these recommendations were made to Illustrious Kevin Hecht, 33°, Deputy of Connecticut and to the Supreme Council.

Named for Leon M. Abbott, Sovereign Grand Commander from 1921 to 1932, the Scholarship Program provides financial support for the continuing education of young men and women from Scottish Rite families and Masonic-related youth groups. Since 1951, more than \$4 million has been awarded to students from each state of the Northern Masonic Jurisdiction.

Eligibility: Those meeting any of the following criteria are eligible to apply for the 2023 Abbott Scholarship program:

A Scottish Rite Mason of the Northern Masonic Jurisdiction. A student directly related (by bloodline or by legal means) to a Scottish Rite Mason in the

Northern Masonic Jurisdiction, or a member of a youth organization sponsored by the Masonic fraternity in the Northern Masonic Jurisdiction who is:

A high school senior, currently accepted at an accredited trade school, who has attained a minimum grade point average of 2.75 on a 4.0 scale.

A high school senior, or undergraduate, or graduate student currently enrolled at an accredited college or university. A member of DeMolay, Rainbow or Jobs Daughters in the Northern Masonic Jurisdiction, or a student from the Dyslexia Learning Center who is a high school senior or is currently enrolled at an accredited college or university, who has attained a minimum grade point average of 2.75 on a 4.0 scale.

The State Scholarship Committee received a total of Forty Five applications for the Abbott Scholarships from Four Valleys in Connecticut. There were no Applications from Norwich this year but 3 were reported coming in late. The Norwich elected to award 3 Valley Scholarships to the 3 Applications they received on their own. The 11 recipients of this year's Abbott Scholarships, and all recipients of the Valley Scholarships demonstrated excellence and genuine financial need. Impressive letters of recommendations from teachers, professors and academic counselors supported all applications. Recipients also exhibited extensive volunteer community service, broad extracurricular activities, leadership and honors/awards in sports, music and drama. Many are holding part-time jobs during the school calendar year and full-time summer employment to help pay for their college costs.

This year, of the Five Valleys in Connecticut, awarded 11 Abbott Scholarships and 34 Valley Scholarships for a total or 45 Scholarships. There were 45 Scholarships received this year:

- Norwich 3

REPORT ONF THE COMMITTEE ON STRATEGIC PLANNING

To the Illustrious Commander-in-chief, officers, and Brethren of the Connecticut Council of Deliberation in session in Shelton, Connecticut on September 23, 2023. The Committee continues to address issues of membership retention, the continuing cooperation between the Valleys, and the family life events offered.

Membership:

We continue to remind our membership that each of us are ambassadors for the Scottish Rite. We need to keep our lodges informed of our activities by mentioning them at meetings. We should speak to newer Masons about expanding their Masonic knowledge by becoming involved with the Scottish Rite. We should inform them about The Path Forward, and direct them to the Not just a man. A Mason website. As always, our biggest challenge is retention. Valley officers and leaders should reach out to current members on a regular basis. There are many media tools like constant contact, websites, social media outlets, virtual meeting programs, the Connecticut Freemasons publication, brother to brother calling programs, and the Valley newsletters which may be put to use. As always, these information highways need to be consistent and content updated frequently, lest we lose the interest of those we are trying to keep and attract.

The Valley of Norwich, with the return to performing live degrees, continues to attract and retain members through multiple reunions. These reunions are great opportunities for Valley membership involvement, and fellowship. Another opportunity for Valley involvement is the North Stonington fair, clam fritter and chowder Booth. This event continues to bring members of the valley together to help raise money for the Children's Dyslexia Center of Connecticut and shows the public the good work the fraternity does for the community.

The Valley Of Hartford has done a better job of scheduling activities for all 12 months of the year. The heads of the bodies are responsible for specific months. In addition to scheduling their degrees, they also plan other events in those months, including their summer months. The events can be family trips, movies, making phone calls to brothers, blood drives, game nights, etc. These events promote engagement among the brothers. A family life coordinator was appointed. It is still the responsibility of the heads of the bodies to come up with the family life ideas. The family life coordinator is the point person to keep track of everything and report to the executive Council.

The valley of Bridgeport held 11 reunions over the last year with at least one live degree for every live meeting with numerous video options. In addition, the valley of Waterbury held five reunions and presented 7 degrees. The valley of New Haven also presented three reunions and 4 degrees. The Valley Of Norwich looks to hold more family life events to help assist in membership retention. The Valley is grateful to the Valley Of Hartford for involving the Valley Of Norwich and their many family life events. The Valley of Bridgeport held, 13 family life events, Valley of New Haven held 2 family life events, and the Valley of Waterbury held 4 family life events. Some of these events included cornhole tournament, family game night, St. Patrick's Day dinner, St. Patrick's Day parade, summer, picnics, Octoberfest, scotch and cigar nights, fishing trips, trip to Lexington and a Boston Red Sox game, dinner, and show at the Goodspeed opera house, Bridgeport, youth, symphony, installation dinner, and Christmas party. The Valley of New Haven held last year's council of the liberation and the Valley of Waterbury holding this year's session.

Valley Of Hartford's membership has dropped from 1400 to 600 over the past eight years. The valley has a very high percentage of senior brothers (>80 years old) compared to

other valleys. The Valley has been doing a great job of retaining brothers, but need to step up recruitment. The valley of Bridgeport saw a gain of six members with a total of 517 members with 24 additions, three restorations, 44 deaths and no NPD's. The heads of the bodies need to do more to engage with new members and get them involved. Degree directors should ask new members to take part of the degrees. Once these members become involved, they will talk to their lodge brothers about Scottish Rite. We will also have trained brothers visit lodges and make presentations. The Valley of Norwich, assisted in holding a joint consistory day in the spring with the other consistories in the state. This continues to strengthen relations and cooperation within the state. The Valley of Bridgeport assisted with a Consistory Day and looks forward to participating again next year. There should be more engagement among the Valleys. Degree teams can visit other Valleys to portray a degree, or joint degrees can be arranged. Also, when a Valley plans in activity, other Valley's should be invited to participate.

In April 2023, the Valley of Hartford worked with Valley of Bridgeport and Valley of Norwich to portray both the 24th and 32nd°.

Children's dyslexia center:

The Valley's continue to support the Children's Dyslexia Center. However, the pandemic continued to impact the events. In Waterbury, the walk, saw lower participation. The Hartford 5K returned this year as well as the Thanksgiving Day Turkey Trot in Stratford, but with smaller numbers. The Valley of Norwich was able to hold the clam chowder and fritter booth at the North Stonington fair again this year, enabling the Valley to continue with support of the Dyslexia Center. Valley Of Bridgeport for the second year a virtual walk on Valentine's Day that was successful, but not as successful as the previous year. The valley of Bridgeport also held its annual turkey trot and the Valley of Waterbury,

also held their annual walk as well. The continued support of individuals and cooperation is vital to the success of the Waterbury campus and our satellite operations.

Conclusion:

In conclusion, all the Valleys that form the Council of the Deliberation should continue to focus Scottish Rite in Connecticut as a whole. They should continue to be more engagement among the Valleys. We should continue to push degree teams to visit other valleys to portray a degree or encourage joint degrees. We encourage Valleys to invite the other Valleys to family life activities. Our brethren desire and need communication, not only from their own Valley, but from all the Valleys to support them. Enhanced communication across the Valleys continue to strengthen Scottish Rite in Connecticut, and offer more opportunities to our members.

RULES AND REGULATIONS

FOR THE CONNECTICUT COUNCIL OF DELIBERATION ANCIENT ACCEPTED SCOTTISH RITE OF FREEMASONRY

ARTICLE I

Title and Allegiance

- **Sec. 1** This Council shall be known as "Connecticut Council of Deliberation of the Ancient Accepted Scottish Rite of Freemasonry."
- **Sec. 2** It is formed under and hereby acknowledges and yields allegiance to the Supreme Council of Sovereign Grand Inspectors General of the Thirty-third and last degree of the Ancient Accepted Scottish Rite of Freemasonry for the Northern Jurisdiction of the United States of America, having its Grand East in the city of Lexington, Massachusetts.

ARTICLE II

Meetings, Notices, Quorum

- **Sec. 1** The Connecticut Council of Deliberation shall meet annually. The time and place of each Annual Meeting shall be determined by the Council, provided, however, that such time and place of meeting may be changed by the Deputy for any reason deemed by him to require such action.
- **Sec. 2** A special meeting of the Council may be called by the Deputy for such time and place within this state as he shall determine, or by this council at any annual meeting.
- **Sec. 3** Written or printed notice of each annual or special meeting of this Council shall be given by the Secretary, to be served either personally, by mail, or by electronic media to each member at least ten (10) days before said meeting. Such notice shall state the purpose thereof.
- **Sec. 4** Accredited representatives of a majority of the Scottish Rite Bodies in this state shall constitute a quorum for the transaction of business.

ARTICLE III

Members, Officers

Sec. 1 The members of this Council of Deliberation shall be such as are prescribed by the Supreme Council.

Sec. 2a The Council shall elect the following officers at each annual meeting to hold office for one year or until their successors shall be elected and installed:

First Lieutenant Commander

Second Lieutenant Commander

Minister of State

Chancellor

Prior

Treasurer

Secretary

Hospitaler

Master of Ceremonies

Seneschal

Standard bearer

Guard

Sentinel

Sec. 2b The Commander-in-Chief shall appoint a member of this Council of Deliberation as Grand historian who shall keep a record of all events of historical significance and report thereon to this Council annually.

Sec. 3 In case of vacancy in any office, by death, removal from the jurisdiction or otherwise, or failure to elect officers in this Council, the Illustrious Commander-in-Chief may make appointments to be in force until the next annual meeting.

Sec. 4 Each officer of this Council shall perform the duties customarily incident to his office in accordance with Masonic usage and shall perform such other duties as may be assigned to him by resolution of this Council or by the Illustrious Commander-in-Chief.

Sec. 5 The officers shall be installed at the annual meeting or as soon thereafter as practicable.

Sec. 6 Scottish Rite Bodies in this State may elect members of the Rite in good standing in the Northern jurisdiction as Honorary Members under such rules and regulations as their By-Laws may prescribe; provided, however, that no member of a Valley may be elected an Honorary member of the Valley in which he is a member.

Sec. 7 Semi-public installation of the officers of Scottish Rite Bodies in this State is permitted.

Sec. 8 A personal contact shall be made with each resident Connecticut member of the Scottish Rite before he can be suspended or dropped from membership for non-payment of dues and assessments. The Trice Potent Master of each Valley shall be responsible for the personal contact in his Valley. The Secretary shall retain the report for future reference and the records.

Sec. 9a This Council of Deliberation authorizes the holding of dual memberships for members of the Scottish Rite in the Northern Masonic Jurisdiction.

Sec. 9b A member of the Rite holding membership in a Valley outside of this State may apply for dual membership in a Valley in this State provided dual membership is permitted in the State of his membership, or a waiver of jurisdiction is obtained.

Sec. 9c A dual member shall be required to pay the customary dues of the Bodies which he joins, but no fee becoming a dual member shall be charged.

ARTICLE IV

Standing Committees

Sec. 1 At the close of each annual meeting, the Illustrious Commander-in-Chief, or in his absence the presiding officer, shall appoint the following Standing Committees to continue in office until a new committee be appointed:

Committee on Business

Committee on Credentials

Committee on Dispensations and Charters

Committee on Finance

Committee on Meritorious Service Award

Committee on Necrology

Committee on Next Place of Meeting

Committee on Nominations

Committee on Rules and Regulations

Committee on State of the Rite

Committee on Insurance

- **Sec. 2** The Committee on Business shall review the address of the Illustrious Commander-in-Chief and shall make recommendations regarding the appointment and disposition of the several parts of the address.
- **Sec. 3** The Committee on Credentials shall pass on the qualifications of every person presenting himself for attendance at each annual or special meeting of this Council and to report thereon at such meeting.
- **Sec. 4** The Committee on Dispensations and Charters shall investigate every application for a dispensation or charter and make a written recommendation thereon to this Council.
- **Sec. 5** The Committee on Finance shall audit the books and accounts of the Secretary, Treasurer, and Hospitaler and make a written report thereon at the annual meeting of this Council. It shall prepare and present a budget of estimated receipts and expenditures for the ensuing year.
- **Sec. 6** The Committee on Meritorious Service Award shall consist of the Presiding Officers of the Bodies of the Rite in the State, who shall present recommendations in writing through the Chairman of the Committee, to the Commander-in-Chief prior to each Council of Deliberation annual meeting.
- **Sec. 7** The Committee on Necrology shall report at each meeting of this Council the names, degrees, titles, and date of death, of all members of the Supreme

Council in this State dying during the preceding year, together with similar data on such other outstanding Masonic leaders as it may deem proper.

- **Sec. 8** The Committee on Next Place of Meeting shall recommend at each annual meeting of this Council a place for subsequent annual meeting or meetings of this Council.
- **Sec. 9** The Committee on Nominations shall consist of the members of the Supreme Council accredited to this State. It shall be the duty of such Committee to nominate candidates for election to the offices of this Council at each meeting place.
- **Sec. 10** The Committee on Rules and Regulations shall consider all matters pertaining to the laws, rules, regulations, and jurisprudence referred to it by the Deputy or by this Council and shall make recommendations thereon.
- **Sec. 11** The Committee on State of the Rite shall consider throughout the year all matters pertaining to the State of the Rite in this State, make recommendations to the Deputy from time to time, and it shall make a written report to this Council at each annual meeting.
- **Sec. 12** The Committee on Insurance shall consist of three members who shall administer all insurance and related matters pertaining to the Scottish Rite Bodies in the State of Connecticut.

ARTICLE V

Finances

- **Sec. 1** The Secretary of each Body of the Rite in this State shall, annually, at least 7 days prior to the annual meeting, forward to the Secretary of the Council of Deliberation a remittance of the per capita tax of not more than five dollars (\$5.00) (as amended 8/15/2007; and on 9/14/2019) per each member on its roll of membership as of June 15.
- **Sec. 2** This Council at any annual or special meeting may vote assessments on the Bodies of the Rite in this State as this Council shall deem proper, provided, however, that every such additional assessment shall be designated for some particular purpose and shall be used only for that purpose.
- **Sec. 3** The fiscal year of this Council shall begin on the first day of August in each year and shall end on the 31st day of July in the next succeeding year.
- **Sec. 4** No money shall be drawn on the Treasurer except upon a warrant signed by the Secretary, countersigned by the Illustrious Commander-in-Chief, and issued in payment of an appropriation or in accordance with an order previously made by this Council.
- **Sec. 5** The Secretary, Treasurer, and Hospitaler of this Council of Deliberation shall be bonded in such manner and in such amount as shall be determined by resolution of the Council, or in default of such determination then determined by the Deputy, the premium on such bonds to be paid by this Council.

ARTICLE VI

Jurisdiction of Valleys

Sec. 1 Each Valley in this State shall have concurrent jurisdiction within the State of Connecticut.

ARTICLE VII

Meritorious Service Award

Sec. 1a An award be known as the "Arthur M. Brown, 33°, Meritorious Service Award" is hereby renamed for the State of Connecticut to be known as the "Frederick H. Lorenson, 33°, Meritorious Service Award". It shall be conferred upon Scottish Rite Masons who, by reason of meritorious services of a masonic character, are worthy and should be so cited.

Sec. 1b The award shall consist of a jewel in memory of the late Deputy for this State, Ill. Frederick H. Lorenson, 33°.

Sec. 1c The recipients must have received the grade of Sublime Prince of the Royal Secret.

Sec. 1d The Awards presented in any State in any one year shall not exceed a maximum of two recipients from each Valley, but not cumulative, provided that an additional special allocation for any Valley may be made by the Deputy for the State. [ART. 905(d) 2013]

Sec. 2a The following procedure shall be followed by this Council relative to selecting those who are to receive such awards and in presenting the awards to those selected.

Sec. 2b The presiding officers of the Bodies of the Rite in the State shall present recommendations in writing to the Council of Deliberation, nominating the member or members of their Bodies whom they feel should receive the award. No presiding officer is eligible to receive this award while he is involved in the nominating process.

Sec. 2c Such nominations shall be referred to the Standing Committee on Meritorious Service Award at least one month prior to the annual meeting of this Council, except that by unanimous consent of this Council nominations may be referred to the Committee at the annual meeting for consideration at that annual meeting.

Sec. 2d The Committee on Meritorious Service Award shall consider the nominations referred to it from the various Valleys and shall make recommendations to the Deputy, at each annual meeting thereof, of members of the Rite in this State to receive the Meritorious Service Award.

Sec. 3 The presentation of the award and insignia shall be made by the Deputy, or someone selected by him. Such presentation shall be made either in the Valley in which the recipient is a member or at the meeting of the Council of Deliberation, as the Deputy may determine.

Sec. 4 The jewel shall consist of an ornamented gold bar, one and a half inches long, with the words "Connecticut Council of Deliberation" in gold letters set in

red enamel. A second gold bar, one and a quarter inches long, is suspended from the first bar by 5 gold links. On this bar shall be the words "Frederick H. Lorenson, 33°, Meritorious Service Award" in gold letters set in red enamel. A double headed eagle, emblem of the Thirty-Second Degree, is suspended from this second bar by three gold links. The figures "32" are of gold set in a triangle of black enamel. The height of the jewel shall be two and three-quarters inches.

ARTICLE VIII

Amendments

Sec. 1 By Amendment of the Supreme Council Constitutions, etc. Upon amendment of the constitutions and regulations of the Supreme Council of Sovereign Grand Inspectors General of the Thirty-third and last degree of the Ancient Accepted Scottish Rite of Freemasonry for the Northern Masonic Jurisdiction of the United States of America, or upon the promulgation or any decree of said Supreme Council, inconsistent with any provision of these Rules and Regulations, then in every such event, and without any further act or deed whatsoever, these Rules and Regulations shall be deemed to be and shall be automatically amended in conformity therewith.

Sec. 2 By Council of Deliberation, these Rules and Regulations may be amended at any annual meeting of this Council by a majority vote of the members present, provided the proposed amendment or amendments have been presented at the preceding annual meeting, and due notice thereof shall have been given to the members and provided, further, that an amendment or amendments may be adopted at the annual meeting at which it is presented, by a two-thirds vote of the members present, thirty (30) days' notice of the proposed amendment or amendments having been given to the members.

Sec. 3 All By-Laws, Rules and Regulations previously adopted by this Council are hereby rescinded.
